This book is the result of a joint effort between a research project organized by the International Peace Research Institute, Oslo (PRIO) and Project LINK. The PRIO project was directed by the five editors of this volume, in cooperation with Dan Smith, PRIO's Director. Formal collaboration with Project LINK started in 1994, after preliminary presentations of the project had been made at the LINK Fall 1993 meeting in Beijing and at the Spring 1994 meeting in New York. The LINK membership was canvassed with a proposal to contribute to the project. A session with presentations of a few preliminary papers was held at Salamanca in September 1994. Finally, the LINK Spring meeting at the United Nations in New York in March 1995 devoted a session to the peace dividend; in addition, a special one-day meeting was held in advance of the LINK meeting itself.
